General Terms and Condition for pre-qualification :

1. Quantity requirement may vary by 10% for which bidder should be prepared accordingly.

2. The stalls should be ready for occupation and there won't be any advance payment.

3. Vendor should be available at event throughout schedule for ready service for which person contact number should be provided.

4. Transport cost of material, furniture, equipment etc required for structure installation at IIT campus should be included in quoted price.

5. There should not be any hidden cost other than quoted price.

6. Any additional quantity requirements can be charged at the pro-rata basis.

7. Applicable GST rate should be confirmed and quoted by bidder.

8. Bidder should be from Mumbai region considering the scale of customized structure which may change within 10% and considering that bidder should be available throughout the event.

9. Cost of wiring for stalls - plug point, metal heliade, MCB(3 days) should be included in quoted price.

10. Damages, if any would have to be borne by the vendor.

11. Unsolicited bids will not be accepted.
