## Introduction

- **Context**

Today, the world is on the crossroads of the energy contradiction, wherein, on one hand, there are billions who do not have access to energy and on the other hand use of energy is resulting in climate change. According to the International Energy Agency (IEA) Report, more than 1 billion people lack access to electricity while over 2.8 billion people lack access to clean cooking. As per the IPCC report of Oct. 2018, we need to have a **“rapid and far-reaching” transition in energy usage**. For mitigating climate change, there is an urgency to reduce the carbon emissions, and the world has to become net carbon zero by the year 2050, an extremely difficult task to achieve. In case the world fails to mitigate climate change, the global temperature is expected to rise up to 5°C by the end of this century in business as usual scenario, in which condition human existence itself will come under threat.

- **SoULS Initiative**

At Indian Institute of Technology (IIT) Bombay through its Solar Urja through Localization for Sustainability (SoULS, [www.soulsiitb.in](http://www.soulsiitb.in)) initiative has been working on the facilitating localized solar solutions involving local communities in assembly, distribution, repair and maintenance, and even manufacturing of the solar products. These localized solar solutions can be a solution to both the issues of energy access as well as the mitigating the climate change. Through this SoULS Initiative, over 5 million families have benefitted through Solar Urja lamp project and more than 9,000 local people, particularly women, have earned some income through technology-based livelihoods. The SoULS Initiative is currently being implemented in 10 Indian states, covering the most marginalized families living in geographically isolated and remote areas. In addition, the initiative also helps local to open solar marts and even set up manufacturing units. The SoULS initiative has been working to develop open source hardware for solar based products. It has also developed solar PV based cooking solutions. Overall SoULS initiative has been working to **provide 24x7 solar energy solutions by locals for locals**.

- **The Idea of Energy Swaraj**

In the backdrop of energy access and climate change, an idea of **“Energy Swaraj”** or localized energy self-sufficiency has been conceptualized. Solar energy is infinite and use of solar energy to fulfil ALL our energy needs locally through the local operations of assembly, manufacturing, installation and maintenance, as much as possible, is energy swaraj. It is a condition of localized energy self-sufficiency, it is localized self-reliance of energy. In order to propagate Energy Swaraj, **Gandhi Global Solar Yatra** (GGSY, [www.ggsy.in](http://www.ggsy.in)) is planned not only in India but across the globe. The young generation, who will bear the maximum burden of climate change, has to be an integral part of this clean energy revolution. A workshop on 2nd Oct. 2019 is being organized across the globe to make millions of people, especially students, a Students Solar Ambassadors.

### **Student Solar Ambassador workshop, 2nd Oct. 2019**

The Student Solar Ambassador Workshop, the seed concept of the Gandhi Global Solar Yatra, aimed to sensitize the young (future) generations who will be bearing the maximum burden of climate change. Their sensitization and participation as solar ambassadors in climate mitigation efforts are important. Therefore, a workshop to train students and sensitize them towards solar energy is being organized on 2nd October 2019, marking the 150th birth anniversary of Mahatma Gandhi, who epitomized the cause of non-violence (principles). This will be a mega-global event, wherein more than 1 million students from over 180 countries will get hands-on training to assemble their own solar study lamp. The workshop is expected to happen in at least 10,000 locations. 2nd Oct. 2019 is marked as 150th birth anniversary of Mahatma Gandhi, which is also celebrated as the International Day of Non-Violence. All the Students Solar Ambassador on 2nd Oct. will also take a pledge of Non-Violence towards Environment. A similar workshop was also organized by IIT Bombay (Guinness World Record event) on 2nd Oct. 2018 across India wherein more than 1.30 lakh students from 857 schools assembled their own solar study lamps.

### **Target**

The target of Student Solar Ambassador workshop of 2<sup>nd</sup> Oct. 2019 is to conduct hands-on training for **2.5 million** students in India and about **0.5 million students** outside India.

## Section 2 – Eligibility Criteria

**The bidder should provide the following relevant documents, failing which their applications shall be summarily rejected:**

1. The bidder has to be operational for last three years in India – (Copy of Certificate of Incorporation / Registration of firm to be enclosed).
2. The bidder should provide **PAN CARD** of the firm. (copy to be enclosed).
3. The bidder should provide **Valid GST Registration Certificate** (copy to be enclosed).
4. The bidder must not be blacklisted / Suspended or any service related dispute with any Organization / Govt org/ PSU /Private Sector inside India or outside India. Declaration to be submitted as per **Annexure A1**.
5. The Bidder's should accept Tender Terms & Condition **Annexure A2**.
6. The Bidder should submit filled Income Tax Return acknowledgment for last two years i.e. A.Y.2017-2018 (F.Y. 2016-17) & A.Y.2018-2019 (F.Y. 2017-18) **Annexure A3**.
7. Duly filed Bidder's Information **Annexure – A4**.
8. The Organization should have produced and sold more than 10,000 solar LED lamps – copy of ( purchase orders to be enclosed) **Annexure – A5**.
9. The bidder should duly fill the compliance sheet and submit the same as **Annexure – A6** (Mandatory)

### **Section 3 - Instructions to Bidders**

**A) Submission of Tenders:**

1. Tender should be submitted on the schedule with your covering letter in the enclosed form duly signed. Your quotation must be submitted in two envelopes Technical Bid and Commercial Bid superscribing on both the envelopes the tender no. and the due date and both these sealed covers are to be put in a bigger cover which should also be sealed and duly superscribed with our Tender No. & Due Date.
2. The Bid should be dropped in the tender box kept in the office of concerned Department / Section mentioned in the tender. No tender is to be handed over to our staff personally unless otherwise specified. All communications are to be addressed to the undersigned only. In case due date happens to be holiday the bid will be accepted and opened on the next working day.
3. The bid can be submitted in person or through post/ courier (IIT Bombay shall not be responsible for any postal delays or any other reason for not submitting the bid in the specified time and resulting in disqualification / rejection of any bid) so as to reach on or before the due date and time.
4. The leaflets catalogue, etc. should be sent invariably so that a proper evaluation of the solar items offered is possible.

**B) COST OF BIDDING :**

1. The Bidder shall bear all costs associated with the preparation and submission of its Bid and the Purchaser shall not be responsible or liable for those costs regardless of the conduct or outcome of the bidding process.

**C) VALIDITY OF THE BID :**

1. 180 Days from the date of submission of bid.

**D) AMENDMENT OF BIDDING DOCUMENTS :**

- 1 At any time prior to the deadline for submission of bids, IIT Bombay may, for any reason, whether on its own initiative or in response to the clarification request by a prospective BIDDER may modify the bid document.
- 2 All prospective BIDDER's who have downloaded the bidding document may visit IIT Bombay website for amendments / modifications which will be binding on them.

**E) DEADLINE FOR SUBMISSION OF BIDS :**

1. Bids must be received by IIT Bombay before the due date and time at the address specified in the tender document. In the event of the specified date for the submission of bids being declared as a holiday for IIT Bombay the bid-closing deadline will stand extended to the next working day up to the same time.



**F) BID OPENING PROCESS:**

1. In two envelope cover bid system, the Technical Bid will be opened in the first instance in the presence of representatives of the bidders at IIT Bombay.
2. Financial bids of only those bidders, whose bids are found technically qualified, by the Technical Evaluation Committee, will be opened in the presence of the vendor's representatives subsequently at later date for further evaluation.
3. One authorized representative of each of the bidder would be permitted to be present at the time of aforementioned opening of the bids.
4. The authorized representatives of bidders, present at the time of opening of the bids shall be required to sign an attendance register as a proof of having attended the bid opening meetings.

**G) LATE BIDS :**

1. IIT Bombay will not be responsible:
  - a. For delayed / late quotations submitted / sent by post / courier etc.
  - b. For submission / delivery of quotations at wrong places other than the mentioned in the tender.
  - c. Any bid inadvertently received by IIT Bombay after the deadline i.e. due date & time for submission of bids, will not be accepted and returned.
  - d. Fax / E-mail / Telegraphic / Telex tenders will not be considered.

**H) SUPPLEMENTARY OFFER /MODIFICATION OF ORIGINAL BID:**

1. Tender submitted against Notice Inviting Tender (NIT) shall not be returned in case the tender opening date is extended / postponed. Bidder desirous to modify their offer / terms may submit their revised / supplementary offer (s) within the extended Tender Opening Date (TOD) by clearly stating to the extend of updation done to the original bid. The purchaser reserves the right to open the original offer alongwith the revised bid (I).

**I) CONFIDENTIALITY :**

1. Information relating to the evaluation of bids and recommendation of contract award, shall not be disclosed to Bidders or any other persons not officially concerned with such process until information on Contract award is communicated to all Bidders.
2. Notwithstanding, from the time of Bid opening to the time of Contract award, if any Bidder wishes to contact the Purchaser on any matter related to the bidding process, it shall do so in writing.

**J) EVALUATION OF BID :**

1. IIT Bombay evaluate technical and commercial acceptable offers on landed net Price basis.
2. In case any BIDDER is silent on any clauses mentioned in this tender documents, IIT Bombay shall construe that the BIDDER has accepted the clauses as per the invitation to tender and no further claim will be entertained.
3. No revision in the terms and conditions quoted in the offer will be entertained after the last date and time fixed for receipt of tenders.
4. Bidders have to submit samples for inspection as mentioned in technical specification.

**K) COMMERCIAL BID :**

1. Quoting of Price (s) : Price quoted should be in Indian Rupees for Commercial Bid -I .
2. Commercial Bid II is for Logistics cost for specified countries and should be quoted in relevant currency. The logistics cost should include allied expenditure, handling materials & transportation cost for supplying to the material to the specified delivery location. **It is mandatory to quote for all the countries.**
3. COMMERCIAL BID must be submitted in enclosed Commercial Bid Form only.If the price is not quoted in Price Bid Form only provided in tender document then, IIT Bombay will reject bid.
4. Tender will be taken as exclusive of all Taxes. Taxes to be mentioned separately in Taxes column.
5. If supplier wish to give pricing details it may be attached in separate sheet.

**L) TRANSFER AND SUBLETTING :**

1. The seller shall not sublet, transfer, assign or otherwise part with the acceptance to the tender or any part thereof, either directly or indirectly, without the prior written permission of the Purchaser.

**M) CANCELLATION OF TENDER :**

1. Notwithstanding anything specified in this tender document, Purchaser / IIT Bombay in his sole discretion, unconditionally and without assigning any reasons, reserves the rights: MMD, IIT Bombay
  - a) To accept OR reject lowest tender or any other tender or all the tenders.
  - b) To accept any tender in full or in part.
  - c) To reject the tender offer not confirming to the tenders terms.
2. To give purchase preference to Public Sector undertakings when applicable as per Govt. Policy/Guidelines.
3. Offer which deviates from the vital conditions (as illustrates below) of the tender shall be rejected:
  - a) Non-submission of complete offers.
  - b) Receipt of offers after due date and time and or by email / fax (unless specified otherwise).
  - c) Receipt of offers in open conditions.
4. Conditional Tenders and Unsigned Tenders will also be rejected.

**N) Exemption from submission of EMD:**

1. Bidders registered with any of the following agencies/ bodies as per Public procurement policy for Micro & Small Enterprises (MSME) order 2012 are exempted categories from payment of EMD provided that the registration certificate issued by any one of these below mentioned agencies must be valid as on close date of tender. Micro small or medium enterprises who have applied for registration or renewal of registration with any of these agencies/bodies but have not obtained the valid certificate as on close date of tender are not eligible for exemption.

i) Khadi and Village Industries Commission (KVIC)

ii) National Small Industries Corporation (NSIC)

iii) Any other body specified by Ministry of MSME/GOI

**To avail exemption it is mandatory to submit valid certificate copy along with technical bid which certificate must be mention activity .**

## Section 4 – Terms and Conditions

### A) Award of Contract :

1. IIT Bombay shall award the contract to the technically qualified eligible BIDDER whose bid (commercial bid-I & commercial bid-II) has been determined as the lowest evaluated commercial bid for all the countries.
2. If more than one BIDDER happens to quote the same lowest price, IIT Bombay reserves the right to award the contract to more than one BIDDER or any BIDDER.
3. If L1 bidder withdraws the contract then L2 bidder will be awarded the contract on L1 rates if accepted and L1 bidder will be debarred.
4. The selected supplier will abide by all the Terms & Conditions of the Tender Document.

### B) Earnest Money Deposit & Performance Bank Guarantee :

1. Quotations exclusively submitted in the enclosed performa will only be considered. However, it should be sent along with a covering letter and Bank Guarantee of Rs. 30,00,000/- (Rupees Thirty Lakhs only) as Earnest Money Deposit as per enclosed.
2. Earnest Money Deposit will be returned to the unsuccessful vendors within 30 days after the award of the contract.
3. EMD of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or derogates from the tender in any respect within the period of validity of its tender.
4. Further, if the successful tenderer fails to furnish the required performance security within the specified period, its EMD will be forfeited.
5. We reserve the full right to reject any offer without assigning any reason.
6. IIT Bombay reserves the right to add more suppliers during the rate contract if necessary and the rate contract vendors should have no objection on the same.
7. We may remove or add any vendor during the contract.
8. Any Vendor currently engaged in litigation with other Organizations, must inform their status in writing.
9. **Performance Guarantee Bond is mandatory.**
10. Successful tenderer/ bidder should submit performance guarantee as prescribed above to be received in the office of Deputy Registrar, Materials Management Division on or before 30 days from the date of issue of Rate contract copy . The performance guarantee bond to be furnished in the form of Bank Guarantee as per proforma or annexure of the tender documents, for an amount of Rs. 1 crore.
11. The Performance Guarantee Should be established in favor of “**REGISTRAR IIT Bombay**” through any Bank Situated at Mumbai or Outstation with a clause to enforced the same on their local branch at Mumbai.
12. Performance Guarantee Bond shall be for the due and faithfully

performance of the contract and shall remain binding, notwithstanding such variations, alterations for extensions of time as may be made, given, conceded or agreed to between the successful tenderer and the purchaser under the terms and conditions of acceptance to tender.

- 13 The successful tenderer is entirely responsible for due performance of the contract in all respects according to the speed, intent and meaning of the terms and conditions and specification and all other documents referred to in the acceptance of tender.
- 14 The performance guarantee bond shall be kept valid during the period of contract and shall continue to be enforceable for a **period of one year from the date of order acknowledgment or upto warranty period whichever is later.**

**C) Terms of Payments :**

1. 100% Payment within 30 days after delivery and acceptance of the material.
2. GST extra as applicable.
3. Price should be valid for at least One year from the date on which Rate Contract is entered into.
4. In the event of any dispute over this contract, IIT Bombay's decision shall be final and binding.

**D) Quantity ordered and Delivery Schedule**

**Quantity order** – The order for SoUL kits will be placed in the multiples of 25 kits, as per the project requirements. One Purchase Order (PO) will not exceed 100,000 kits. The minimum number of kits to be bought through this tender is 50 thousand which may be increased up to 3 lakh lamp kits.

**For every 25 lamp kits, 1 toolkit will be supplied by the vendor. The list of the toolkit components is as follows:**

**E) Order delivery locations:**

- i. 50 Thousand to 1 Lakh SoUL kits will be sent to multiple Indian Embassies

globally. 1 location per country for around 180 countries

500 Lamp kits (inclusive of 20 toolkits) will be supplied to every Indian Embassy which has accepted the invitation and will be taking part in the event.

- ii. 1.5 Lakh to 2 Lakh Lamp kits will be supplied to special schools within India.
- iii. **There is no guarantee of minimum order for a selected rate contract.** Actual order quantity for each vendor will depend on quantity and quality of supply, timely delivery and capacity of supplier.

**F) Order Lead Time –**

For a given PO, multiple delivery locations with different quantity and delivery date can be given.

The time of delivery of order to the specified location should not be more than 15 days from the scheduled delivery date.

**G) Penalty clause for delay – In case of delay beyond contractual delivery date, penalty will be applicable at 0.5% per week of the basic order value.**

**H) Location of delivery -**

The kits have to be delivered as per requirement across the globe to several countries and to all districts in India.

**I) Delivery Location**

The SoUL kits, along with spare components, toolkits, warranty cards, operation manual, etc will be delivered across the globe to several countries and to all districts in India.

**IMPORTANT NOTE:** Specific locations in different countries and within India will be available after the vendor is selected.

**J) Delivery Timing –** The consignment of SoUL kits must reach the destination on working days, between 9:00am – 5:00pm.

**K) Missing components, Physical and technical defective components -** If the number of missing, physical and technical defective components exceeds 2%, and when identified and notified through due inspection process at the delivered location has to be replaced by the vendor within 10 working days for national consignment and 60 working days for International consignment . The number of missing, physical and technical defective components (all put together) in any consignment of an order delivered at any location should not exceed given percentage of 2% for any single component. If the number of such components exceeds 2%, the vendor will have to replace the missing, physical and technical defective material and penalty will be applicable at 0.5% per week of the basic order value.

- L) Mode of Transport** - The mode of transport is at vendor's discretion.
- M) Packaging-** The consignment packaging should be as per the specifications mentioned at the time of placing the order.
- N) Spare Components** - Spare components shall be made available to carry out replacement activities during the workshop. The spare components will be provided free of cost by the vendors along with the SoUL kit. The proportionate spare components as listed in the table below will be delivered by the vendors as per instructions from IIT Bombay. Additional spares ,if any, as specified during the course of the project must be made available to permit uninterrupted service of lamps. The spares and the replacements of defective components should be done within 10 working days for national and 60 working days for international consignments from the day of reporting the defect. The cost of spares and replacements which includes all cost freight and taxes to be borne by the vendor.

(For example: for supply of each 25 batteries, 3 additional batteries as spare parts should be supplied)

**O) Warranties and Guarantees**

1. Solar Module: Minimum 5 years warranty from the date of Delivery to the respective location.
2. Batteries: Minimum 5 year warranty from the date of Delivery (however as per the technical specification battery is expected to work for minimum 1000 cycles).
3. Electronic accessories (PCB, Switch, Socket, LED, wires): Minimum 1.5 year warranty from the date of Delivery to the respective location.
4. 2% or above material, if received defective will have to be replaced by the vendor. Any physical damaged or technical defects to SOUL kit/components as and when identified through due inspection process at the delivered location has to be collected and replaced by the vendor within:
  - i) 10 working days (within India)
  - ii) 60 Working days (Outside India)With all cost including freight and taxes borne by the vendor.

**IMPORTANT NOTE:** Warranty and guarantee not applicable to physically damaged SOUL kit during assembly process and usage.



## Section 5 – Scope of Work and Technical Specification

For execution of “Student Solar Ambassador Workshop” across the globe, the scope of work for the vendor would be following: (NOTE: Vendor meeting the selection criteria will be submitting technical and commercial bids for SoUL kit supplies. Selected vendor will be based on meeting the requirements laid down by IIT Bombay will enter into rate contract with IIT Bombay) Procurement or manufacturing of SoUL components as per technical specifications mentioned in the contract

1. Testing of SoUL kit components, as per technical specifications mentioned in the contract
2. Liaison with IIT Bombay staff for inspection at the work site of lamp components
3. Packaging and labeling of SoUL kits as per IIT Bombay’s requirement
4. Delivery of SoUL kits to the specified locations across the globe as and when mentioned in order placed by IIT Bombay.
5. Provide proportionate spare components for repair and maintenance along with the order of SoUL kit supply in a separate packing
6. Carry out replacement of faulty SoUL kit components during warranty period in liason with IIT Bombay
