1) The Technical Bid should contain the following details.

a) Successfully completed works during last 7 years ending last day of the month of October 2022 as per 'a' I, II, III and 'b'.

I. Copies of four similar work completed work orders having costing of single work order with work completion certificate for one year period not less than 25% of estimated cost of Rs.99,35,942.00.

or

II. Copies of two similar work completed work orders having costing of single work order with work completion certificate for one year period not less than 50% of estimated cost of Rs.99,35,942.00.

or

III. Copy of one similar work completed single work order with work completion certificate of costing for one year period not less than 80% of estimated cost of Rs. 99,35,942.00.

and

b) Copy of one single work order of any work completed work order with work completion certificate costing for one year period not less than 30% of value of estimated cost of Rs. 99,35,942.00 in Govt or Semi Govt. or Public under taking organization.

- c) Certificate copies of company registration, PF & ESIC registration, copies of PF & ESIC challan for proof of payment made respective authority for last six months.
- d) Copies of PAN card & Income tax return statement of last three year 2019-20, 2020-21 & 2021-22.
- e) Annual turnover of contractor should be at least 70% of estimated cost during last three financial years (2019-20, 2020-21 & 2021-22.).
- e) Copy of valid bank solvency certificate 40% of estimated amount Rs.99,35,942.00 issued by any Nationalized / Schedule Bank.
- f) Please attached copies of work orders and work completion certificates as per above mentioned in Sr. No.'a'-I, II, III & 'b' only. Please don't attach work order and work completion certificates below 25% of estimated cost.
- g) All bidders should submit EMD amount of **Rs.1,98,719.00** in the form of pay order or demand draft in the Public Health Office IIT Bombay on or before **23/12/2022 upto 05:00 pm**, in favour of "**The Registrar, IIT Bombay**". Also bidders have to submit D.D. or Pay order along with technical documents. Contractor having valid NSIC/MSME certificate should submit the same in Public Health Office instead of EMD on or before the date mentioned above.
- 2) Agency which will qualify in technical bid only those agencies commercial bid will be opened.
- 3) The technical and commercial bids should contain the entire tender documents with authorized signatory and company stamp. The Technical and Financial Bids should be submitted in two separate envelopes sealed with cello tape or wax. Please mention the name of work & address on the envelope.
- 4) Use of correcting fluid, anywhere in tender document is not permitted. Such tender is liable for rejection.
- 5) Pre-bid meeting is on **14/12/2022 at 11:30 am** in Public Health Office for the contractors those who have purchased the blank tender documents from Public Health Office.
- 6) If re-tendering of same contract is done due to less than three contractors participation in bidding then during re-tendering tender will not be issued to those agencies who had initially purchased the tender documents, but did not submit their offer during first time tendering process of this work.
- 7) IIT- Bombay reserves its rights to reject any or all applications for issue of blank tender forms, accept and reject any tender or to relax any above conditions without assigning any reason and without any reference.
- 8) Cost of blank tender document will be charged at Rs.5000/- (Rupees Five thousand only) which will be non-refundable.
